REQUIRED DOCUMENTS



The Academy on Charles

I-20, proof of income, and proof of enrollment required. Passport or visa can be used as ID. 3-month security deposit without guarantor.

The Baltimorean

I-20, proof of income, and proof of enrollment required. Passport or visa can be used as ID. No credit check required. No cosigner needed if adequate income is shown. 3-month security deposit without a guarantor.

The Broadview | Woodcliffe Manor

I-20, proof of income, and proof of enrollment required. Passport or visa can be used as ID.

Carlyle | Marylander

I-20, proof of income, proof of enrollment and ID. Credit Check, Crime Check, Rental History, and Employment Check.

The Charles | Blackstone | Allston | Campus Sq.

I-20, proof of income (pay stubs, stipend letter from JHU), Visa if applicable, passport/photo ID. No cosigner required.

Cresmont Lofts

I-20 and proof of enrollment required. If I-20 shows inadequate income: get a cosigner (US Citizen recommended) or pay double security deposit. Credit check not required.

Guilford Manor | Hopkins House

I-20 and proof of enrollment required. Passport and Visa needed. If I-20 shows inadequate income: get a cosigner (US Citizen recommended) or pay double security deposit.

Jefferson House

Requires a government-issued photo ID. Applicants are screen through a 3rd party that conducts a background check and may require more documentation.

Nine East 33rd

I-20, proof of income, and proof of enrollment required. Passport or visa can be used as ID. Background check. Credit check not required.

Real Estate Dimensions Properties

I-20, proof of income, and proof of enrollment required. Passport or visa can be used as ID. Credit check not required.

St. Paul Court

I-20, proof of income, and proof of enrollment required. No cosigner needed. Must provide Passport or Visa.

The Social

I-20 and Visa/Passport. Security deposit of 1-2 months rent, or if applying with cosigner, \$300 security deposit.

Telephone Building

I-20 and proof of enrollment required. Security deposit is double in lieu of credit check. All non-undergraduate students must show letter of enrollment/grant with length of stay. Part-time students pay higher security deposit.

University West

I-20, proof of income, and proof of enrollment required. Passport or visa can be used as ID. Student can get a cosigner (US Citizen recommended) to lower the security deposit.

Wyman Court

I-20 with proof of income and enrollment required. Security deposit based on income/credit.
