Medical research and medical practice have not merely been incidentally affected by racism in broader society, but rather have been key sites for the production and reproduction of biological understandings of race. In order to develop more effective antiracist responses to endemic health inequalities made so visible in the COVID-19 epidemic, medicine needs to fully confront these painful histories of structural violence. This conference included historians, sociologists, medical educators, medical trainees, advocates and activists from around the United States to work towards a more inclusive version of historical reckoning.
